THE GRAND LODGE OF CANADA AND THE QUEBEC SECESSIONISTS.

Although a course contrary to that which we have consistently advocated has been adopted, we rejoice to announce that there exists a probability that the hitherto widening breach between the two sections of our Canadian brethren will be speedily closed in an amicable manner.

A treaty having been held between representatives of the Grand Lodge of Quebec and those lodges within the district which have remained faithful to their allegiance to the Grand Lodge of Canada, the following resolution has been agreed to :—

“Whereas, unhappily, differences and disputes have arisen, and are now existing in masonry in the Province of Quebec, between the Grand Lodge of Quebec, A. F. and F. M. and her subordinates, on the one part, and the several lodges in the said province still holding under the jurisdiction of the Grand Lodge of Canada, on the other part.

‘And, whereas, with the view to terminate and for ever end said differences, and to restore harmony throughout the craft in the said province, the said lodges, to wit: the said party of the second part, are willing to amalgamate and join with the said party of the first part to wit: the said Grand Lodge of Quebec, and the said party of the first part are willing to accept said lodges into their organisation or Grand body, the same as if they, the said lodges, had originally taken part in said organisation.

“And it is agreed by both said parties that all questions, viz., names of lodges, distribution of property in the case of duplicate lodges, and priority of numbers in the case of all lodges, shall be left entirely to a committee of six, three of whom shall be named from the party of the first part, and three from the party of the second part, with power to said committee to name an arbitrator, and the decision of the said committee and umpire to be final.

“And the committee representing the Grand Lodge of Quebec hereby agree to submit the above terms for the acceptance of their Grand Lodge. And the committee representing the lodges under the jurisdiction of the Grand Lodge of Canada hereby agree to recommend the above terms to the representatives of the lodges, at a meeting to be held by such representatives for that purpose.”

We sincerely hope that this may be “the beginning of the end,” and that once more as loving brethren the masons of Canada may vie with each other in the good work, and that, in its infantile steps the Grand Lodge of Quebec may emulate the steady progress and dignified position of its still youthful parent, the Grand Lodge of Canada.

On this subject the “Craftsman and Canadian Masonic Record” says :—

“At the last annual communication of the Grand Lodge of Canada, the settlement of the Quebec difficulty was referred to the masons of Quebec, with the promise, implied by the passage of the resolution, that Grand lodge would, as soon as an arrangement mutually satisfactory to the loyal Masons and those who have withdrawn from their allegiance to the Grand Lodge of Canada, had been effected, cede the territory embraced within the limits of the Province of Quebec, and make such other concessions as justice required. That resolution, was, we believe, sustained by some brethren who have heretofore professed very strong friendship for the so-called Grand Lodge of Quebec, and the perfect acquiescence in the movement which brought it into existence. The majority by which it was carried was a very large one, and expressions of confidence were freely indulged in upon all sides that the question was in good hands, and that the schism, which all true Masons have so much regretted, was certain soon to be settled.”

**A SILENT TONGUE.**

A member was not long ago expelled from his lodge for divulging the proceedings of the lodge to one not entitled to such knowledge. The action was sustained by the Grand Lodge on the ground that it was of such common occurrence for the proceedings of lodges to be known almost immediately by the outside world, that the expulsion was deemed just. It would be well for every lodge to adopt such stringent measures that would prevent this divulging of transactions which should be kept entirely secret. Many brethren are, perhaps thoughtlessly, too apt to speak in the presence of those who are not members, of things that occur in the lodge. We have known instances where an applicant has been rejected and in a short time afterwards the fact was known among all his acquaintances. This practice is reprehensible, and no doubt if the lodges could fasten the guilt upon the delinquent he would be expelled, as he would richly deserve. One of the inculcations of masonry is a silent tongue, and if the brethren were more guarded there would be less trouble. The newly admitted brother is admonished to be silent, but at times we find the admonition is not heeded.—*Landmark*.

**DESTRUCTION OF GENERAL WASHINGTON'S LODGE ROOM.**

Among the old colonial houses consumed in the conflagration at Alexandria, Virginia, in May last, were the Masonic lodge of which George Washington was the Master, and the old colonial Court House, in which Washington's provincial troops were quartered in 1754, and from the door of which Braddock marched to his defeat in 1775, and in which ex-President Washington gave his last vote in 1760.

**WHY MASONIC HISTORY IS SO BRIEF.**

The fact has not escaped the observation of any intelligent reader that very little, comparatively, has been written of Freemasonry. All that is authentically historic of the institution would make a very small volume. This is certainly not for lack of age. It dates an antiquity of origin that runs far back into the centuries that precede the Christian era. It is not because it has been confined to obscure and unimportant individuals, for it has in all ages been patronized and promoted

by persons of the most consequence, and of the highest distinction, of whom mention is made in history. It is thus accounted for. It has been a grand charity. Its spirit has been benevolence,—its deeds beneficence,—its march has been peaceful, unobtrusive,—going on the principle that the left hand shall not know what the right hand doeth. Then again, I think I shall keep within the limits of truth in asserting that two-thirds of the history of this world is a record of blood, or of of diplomacy and intrigues that have led to the effusion of blood. No wonder, then, that an institution, characterised as this has been, should find so little room on these blood-stained pages. That its friends have not written its history, more complete, is to be accounted for from the fact, as all the initiated know, that masons are not much given to writing—that its essential features are traditional, and if I may be allowed to say so, it has ever inculcated a modesty which forbade going on the housetops to herald its deeds, or sounding a trumpet before it on its missions of love.—*BRO. **MASONIC SAYINGS AND DOINGS ABROAD.**

The triennial convocation of the General Grand Chapter of the United States was held at Baltimore last month. It was decided that hereafter the use of substitutes in conferring the R. A. degree in chapters may be lawfully used.

An amendment to the constitution, making the Past Grand High Priests of the different States represented in that body, life members, was adopted.

An amendment to the constitution was offered, which lies over under the rule, making the first four General Grand Officers life members of the General Grand Chapter.

The decision of the General Grand H. P. in relation to the work, and also that relative to his decision for the continuance and perpetuity of the General Grand Chapter from its organisation to the present time, were adopted.

The next convocation of the General Grand Chapter will be held at Nashville, Tennessee, in November, 1874.

## Obituary.

## BRO. GEORGE ELLIS,

The mortal remains of the late Bro. George Ellis, professor of music, were committed to the earth at Blackburn, Lancashire, on Thursday, 12th. inst., with more than usual solemnity. Bro. Ellis exercised his talent and his opportunities to the edification of the public, displaying, on all occasions, the highest musical talent, observing the utmost punctuality in the keeping of his engagements, and the different traits of a public and professional character untainted by narrow views or aggrandisement, but ever trying, with unassuming and vigorous energy of character, to hand down to posterity a musical legacy at once elevating, humanising, and divine. Like all successful men of his class, his worth will be best appreciated after his death, and the loss that the musical world has sustained will only be measured by a correct estimate of the blank that his death has occasioned.

In Blackburn Bro. Ellis was extremely well known, and on the morning of the funeral the town was well astir.

The shop windows in the principal streets were partially closed, and dense masses of people came to pay a last tribute of esteem to an old townsman who had obtained for himself a niche in the temple of fame. The relatives and friends of the deceased gentleman assembled at his residence in Park-Terrace. The Masonic brethren met in their lodge room at the Old Bull Hotel, and at eleven o'clock proceeded to Bro. Ellis's house, and shortly afterwards the funeral cortege filed off, to the strains of the grandly solemn "Dead March in Saul."

As the funeral procession was passing through Penny street on its way to the Cemetery, there were fully 2000 persons in the front of the cortege. A halt was made at the Cemetery gates, the Bacup band went a little forward, and the other bands, with the Masonic brethren, took open order and uncovered; the hearse and the mourning coaches passing between the lines. The band commenced again to play the "Dead March in Saul," and in that way proceeded to the chapel of the Church of England.

The coffin was met at the church door by the Rev. W. Mayor, who repeated those grand lines in the Church of England service, "I am the resurrection and the life." The coffin was of oak, with a brass plate, on which was inscribed the simple sentence, "George Ellis, died October 8th, 1871," and it was circled with a magnificent wreath of flowers.

A choral party went to the Cemetery, consisting of Mr. Jones, Organist of St. Peter's Church, Miss Heaton Mr. Birkett, Mr. D. Towers, Mr. Anthony Green, and Mr. Jennings. A harmonium had also been conveyed to the church, and when all the mourners were assembled and a vast concourse of people had congregated, the choir sang with much sweetness and effect the psalms appointed for that day.

The Rev. W. Mayor then most impressively read the first portion of the burial service, at the conclusion of which the choir sang "Vital spark of heavenly flame," with much feeling and pathos. The body was then borne to a new vault which had been lately purchased by the deceased, made out of two grave spaces. The Rev. Mr. Hughes, of Toekhales, concluded the burial service at the grove side, the people uncovering.

The Masonic funeral ceremony was then gone through. The two hymns, one beginning with—

There is a calm for those who weep,  
A rest for weary pilgrims found;

and the second beginning—

It is decreed in heaven above

That we from those whom best we love must sever.

were sung in such a way as to visibly affect the vast assembly. The Worshipful Master, Bro. Denis Towers, who was deeply moved, concluded by reading an address couched in terms of thrilling eloquence, from which we give the subjoined extract:—"In conformity with this usage, and at the request of our deceased brother, whose memory we revere, and whose loss we deplore, we are assembled in the character of Freemasons, to resign his body to the earth, whence it came, and to offer up his memory, before the world, the last tribute of our fraternal affection; thereby demonstrating the sincerity of our past esteem, and our inviolable attachment to the principles of the Order."
